Enrollment Agreement

This is a contract to provide educational services. To enroll, please complete this contract and return it to the school for processing.

Early Childhood Education Certificate

– 24 units consisting of all 8 modules and 495 instructional hours.

English as a Foreign Language – California College of Early Childhood Education offers classes in English only. No courses in other languages are available. All our recruitment and paperwork are done in English. The College may require international students to take the TOEFL iBT test. All classes and class materials are taught in English. We do not provide ESL or translation services. If English is not the student's primary language, and the student is unable to understand the terms and conditions of the Enrollment Agreement, the student shall have the right to obtain a clear explanation of the terms and conditions and all cancellation and refund policies in his or her primary language.

Our classes are offered at 1670 South Amphlett Blvd, San Mateo, CA 94402. All online classes are held in real time in an interactive classroom. Students must attend courses for all 45 instruction hours.

General Criteria for Admission:

- Students must have a high school diploma (or equivalent) or college degree (if applicable) and be at least 18 years of age.
- All students must submit a copy of a government-issued photo ID.
- International students are required to provide documentation of English language proficiency, which may include taking the TOEFL iBT test.
- No ability-to-benefit students will be admitted into the institution.
- Students must pay all related fees as stated in the current fee schedule when submitting a signed enrollment contract or make other arrangements suitable to the institution.
- This institution has not entered into an articulation or transfer agreement with any other college or university.

Notice Concerning Transferability of Credits and Credentials Earned at Our Institution

The transferability of credits you earn at California College of Early Childhood Education is at the complete discretion of the institution to which you may seek to transfer. Acceptance of the certificate you earn in Early Childhood Education is also at the complete discretion of the institution to which you may seek to transfer. If the credits or certificates that you earn at this institution are not accepted at the institution to which you seek to transfer, you may be required to repeat some or all of your coursework at that institution. For this reason, you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending California College of Early Childhood Education to determine if your credits will transfer.

California College of Early Childhood Education offers one course of study. The total cost for the twenty-four-semester unit (495 clock hours) certificate program is \$4001.70 (ONLINE and ON CAMPUS), which includes tuition/supplies/Admin Fees, \$100 NONREFUNDABLE Registration Fee, and NONREFUNDABLE Student Tuition Recovery Fund. Students may enroll for specific courses rather than the entire program to meet individual needs for employment under California Title 22 Licensing requirements. **UNITS ARE NOT APPLICABLE FOR ANY TEACHING CREDENTIAL OR CHILD DEVELOPMENT PERMIT ISSUED BY THE CA COMMISSION ON TEACHER CREDENTIALING.**

STUDENT TUITION RECOVERY FUND (STRF)

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program.

WITHDRAWAL & COLLEGE REFUND POLICY

The College shall refund the unused portion of tuition if the student does not register for the period of attendance or withdraws therefrom at any time before completion of the course or otherwise fails to complete the enrollment period. A student who withdraws from the College before the first day of classes can receive a tuition refund of 100%, which does not include the non-refundable Registration Fees and Admin Fees. All refunds for withdrawals after the start of school are determined on a pro-rated basis up to the completion of 60% of the course. Pro-rated refunds are calculated by determining the percentage of the course completed up to and including the official withdrawal date. No refund will be granted to a student who chooses to withdraw after completing 60% of the course.

The institution shall pay refunds due on a reasonable or timely basis, not to exceed 30 days after the date the student's withdrawal has been determined. The student has the right to cancel the enrollment agreement and request a refund by submitting a written notice explaining the reason for the withdrawal to Ethel Alandy, California College of Early Childhood Education at 1670 So. ABOUT THE COLLEGE
